



ALICE: 4 COUNTY BREAKDOWN

of Michigan households struggle to afford basic needs like housing, food and child care.



This problem affects families in every city in our region.

- LIVONIA:25% of households fall below the ALICE threshold (BAT)
- BIRMINGHAM:21% of households BAT
- SHELBY TOWNSHIP: 30% of households BAT
- ANN ARBOR:43% of households BAT



EQUITABLE COMMUNITIES OF STABLE HOUSEHOLDS AND THRIVING CHILDREN

Washtenaw Basic Needs Grant Overview

The Washtenaw Basic Needs grant is designed to provide responsive flexible funding for organizations to meet the increased demand for emergency food, homeless services and Medicaid enrollment support following the end to pandemic-era relief programs and greater need for these services in the winter months.



9.8% of residents face food insecurity, but

nearly 4 in 10

food insecure are ineligible for nutrition programs.

Eligible Services: Food Bank, Pantry & Community Kitchen



52% of renters

and **19% of homeowners** spend more than 30% of their income on housing.

Eligible Services: Emergency Shelter, Transitional Housing & Homeless Diversion/Prevention Services



12% of residents

are insured through Medicaid. Through the "unwinding" process household are losing coverage, even among people still eligible.

Eligible Services: Medicaid Enrollment/Redetermination Support





Eligibility Criteria and Funding Priorities

- Funding Range: \$15,000 \$40,000
- Funding Period: 6-months (January June 2024)
- Competitive RFP open to new and currently funded partners
- Must be a 501(c)3 and in stable financial position
- Based in Washtenaw County AND serve Washtenaw County residents
- Organizations with established programs/services in the funding categories
- Focus on ALICE communities
- Programs/services that help people meet their food, shelter and benefit navigation needs in ways that promote access, dignity, and choice and are responsive to the specific needs of their local communities and environments.





Structure of Grant Application

There are seven sections/tasks in this RFP:

- Eligibility Screening
- Organizational Information
- Grant Contact Information
- Program Narrative
- Demographics and Geographic Reach
- Metrics
- Budget





Evaluation Process

- All applications are reviewed by a minimum of three reviewers, including United Way staff members and external volunteers.
- Recommendations are presented to leadership and board of directors for their approval.
- Investment decisions are made based on a variety of criteria, including but not limited to the scoring rubric, geographic scope, gaps in services and client population, all of which are used to identify organizations that have the capability to create the most impact both individually and collectively for Washtenaw County.
- Awards may be less than the amount for which an organization has applied. These decisions are made based on the strength of the application, proposed services, and geographic spread, among other considerations including United Way's overall budget for this RFP and the full portfolio of partners.





Scoring Rubric

- View Scoring Rubric
- Applications scored across seven categories. 51 total points possible.
- Program Narrative:
 - Alignment between acute need, services and qualifications of organization
 - Evidence that services are accessible to client population(s) and offered at convenient times
- ALICE Municipalities: Services target municipalities where the percentage of households that fall below the ALICE threshold is 40% or greater.
- Metrics: Aligned to scope of work and demonstrate careful consideration of success measures.
- Budget:
 - Consistent with scope of work & transparent
 - Evidence that funds can be fully expended within the grant period




Accessing Grant Applications: Switch to Organizational View






Accessing Grant Applications: Select Programs










Accessing Your Application: Switch to Organizational View




