Background context & updates for 2025

Background of Post-Season messaging

The Tax Coalition's year ends with a "post-season" outreach effort beginning on April 16th and ending in November, when the IRS stops accepting tax returns to prepare for the new season. During the post season we aim to reach as many people as possible who have not yet filed their taxes and support them to file, as well as to keep a baseline awareness of the Tax Coalition's services in the minds of community members and partners for the following season. In the post season, the call to action is that it's not too late to schedule an appointment and file taxes for 2025, and that support to file prior-year taxes is also available.

2025 Eligibility

Tax law didn't change significantly for the 2025 season, and there are no changes for the post-season.

- The income limit for no-cost, expert tax preparation assistance through our partners has **increased to \$67,000.**
- The expanded Michigan Earned Income Tax Credit (EITC), first implemented in tax season 2024, is still in effect. For every dollar in EITC credit that residents receive from their federal tax return, they will receive an additional 30% from the State of Michigan when filing their Michigan return.
- The Child Tax Credit still requires a minimum income of \$2500 *earned from working*. The COVID-era exceptions that waived this requirement have not been renewed.

Framing & Key Messages

What could you do with \$1500 or more?

Message testing shows that messages that prompt individuals to imagine what they could do with a specific amount of money are the most effective at motivating action. That’s why our suggested messages generally open with, “What could you do with \$1500 or more?” (\$1500 is the average refund amount for clients of our nonprofit, IRS-certified tax prep partners Accounting Aid and Wayne Metro.)

IRS-certified, expert tax assistance available at no cost to you.

Message testing shows that residents often view “free” resources with skepticism and are suspicious of low quality. Emphasize “IRS Certified” and “expert” and reframe “free” as “at no cost to you”.

Text messaging (preferred)

Our coordinated campaign’s experience shows that text messaging is one of the most effective means to reach individuals about the benefits of filing their taxes.
