#### Background context & updates for 2026

##### Difference between preseason and main season messaging

The tax coalition outreach starts with a “pre-season” outreach push in late November and December 2025 to take advantage of holiday and year-end events to spread awareness. In the pre-season, the call to action is to pre-register for an appointment. In the main season, starting in mid January 2026, this call to action changes to “schedule an appointment”.

##### New for the 2026 season

Recent legislation has made many changes to tax law. The most important changes impacting low-to-moderate income households are:

- The income limit for no-cost, expert tax preparation assistance through our partners has **increased to \$69,000.**
- The **Child Tax Credit** has increased by \$200 per child. New this year, to claim the Child Tax Credit, **the parent (or spouse, if filing jointly) must have a Social Security Number.** (Children also must have a Social Security Number). The Child Tax Credit still requires a minimum income of \$2500 *earned from working.*
- New provisions reduce taxes on earnings from **tips and overtime.** Individuals whose earnings include tips or overtime should see lower taxes and larger refunds. However, the new rules are more complex in practice than they sound. Our trusted, IRS-certified non-profit tax partners will ensure that residents get the maximum refund they are eligible for under the new law.

- The expanded **Michigan Earned Income Tax Credit (EITC)**, first implemented in tax season 2024, is still in effect. For every dollar in EITC credit that residents receive from their federal tax return, they will receive an additional 30% from the State of Michigan when filing their Michigan return.

## Framing & Key Messages

### What could you do with \$1500 or more?

Message testing shows that messages that prompt individuals to imagine what they could do with a specific amount of money are the most effective at motivating action. That's why our suggested messages generally open with, "What could you do with \$1500 or more?" (\$1500 is the average refund amount for clients of our nonprofit, IRS-certified tax prep partners Accounting Aid and Wayne Metro.)

### IRS-certified, expert tax assistance available at no cost to you.

Message testing shows that residents often view "free" resources with skepticism and are suspicious of low quality. Emphasize "IRS Certified" and "expert", and reframe "free" as "at no cost to you".
